# Work Programme of the SIDS Unit (2017 -2018) & Resource Allocation

- 1. Since its establishment, the work programme of the UN-DESA SIDS Unit has been guided by two primary considerations, namely: the implementation of its core and additional mandates; and secondly, its overall alignment to the core functions of the Division for Sustainable Development (the Division)<sup>1</sup>. The latter ensures the equitable allocation of resources to the Unit to enable it to carry out its ever-expending mandates. For the year 2017-2018, the focus of the Division was directed to these five core functions: (a) support to intergovernmental processes on sustainable development; (b) analysis and policy development; (c) capacity development at the country level; (d) inter-agency coordination; and (e) knowledge management, communication and outreach<sup>2</sup>. The Unit's Work Programme for this two years was tailored to ensure the implementation of its core and additional mandates and to mirror the Division's core functions.
- 2. The current full complement of the SIDS Unit was attained in January 2017 following the recruitment of the current Chief of Unit. The Unit's Work Programme in Table 1 & 2 below covers the period 2017-2018.

3. In implementing the above-mentioned Work Programmes, the SIDS Unit has had in the past and continues to benefit from tapping into resources and expertise available to it from other branches and divisions of UN-DESA. This arrangement has directly enhanced the Unit's support to SIDS, including the effective monitoring of the implementation of internationally agreed development agenda including the SAMOA Pathway and the 2030 Agenda. In 2016, the JIU<sup>9</sup> (see: Table 3) highlighted the percentage of time provided to the Unit by other branches in the Division. This percentage of extra support has remained more or less unchanged.

4. However, despite the provision of extra divisional support, the three-professional staff of the SIDS Unit have constantly indicated, that in order to fully meet their deliverables, especially the provision for secretariat support and in the preparation of the mandated parliamentary documentations, including the monitoring of progress in the implementation of the sustainable development priorities of SIDS, they've all had to find time outside normal business hours to complete their undertakings. Table: 4 reflects the percentage of time taken by the Unit's individual professional staff members outside normal business hours to complete their tasks.

### **ALLOCATION OF RESOURCES**

6. In its assessment of the allocation of resources to the Secretariat, the JIU concluded that "resources have remained stable over a period in which the mandates have significantly expanded through successive resolutions resulting in additional tasks" <sup>11</sup> and recommended that "Member States should consider increasing the resources allocated to the SIDS Units of both DESA and OHRLLS to equip them with adequate means to effectively respond to the expectations of SIDS and their development partners" <sup>12</sup>.

### (a) Allocation of Human Resources

At its inception, the UN-DESA SIDS Unit consisted of two established posts: The Chief of Unit (P-5) and a Sustainable Development Officer (P-4). The Secretariat has since taken measures to strengthen the Unit through deployment of additional established posts: (a) an Associate Sustainable Development Officer (P-2), (b) a Website Assistant (G-6), and (c) a General Service staff member (G-4)<sup>13</sup>. A Sustainable Development Officer (P-4) position was requested in the context of the programme budget for the biennium 2008-2009<sup>14</sup>. In addition, extrabudgetary resources was secured with the support of the Government of Greece to provide for an Interregional Adviser (L-4) for a period of one year<sup>15</sup>. An Associate Expert was later assigned to the Unit for two years, with the support of the Government of Italy, in 2008<sup>16</sup>. The current staff establishment of the Unit remains at five, three Professional Officers: P5, P4, P2 and two General Staff Officers: G6 and G4. The Unit continues to benefit from its interaction with the Division for Sustainable Development Goals.

#### (b) Allocation of Financial Resources

8. Successive resolutions of the Assembly have repeated calls on the Secretary-General underscoring the importance of providing the Secretariat with adequate, stable and predictable funding to facilitate the full and effective implementation of its mandates in accordance with the priority accorded to it and in view of the demand for its services, in particular with respect to the provision of assistance and support to SIDS. Table: 6 lists these repeated calls.



9. During the biennium 2016-2017, a sum of \$18,291,300, reflecting a decrease of \$2,589,100 was allotted to the Division for Sustainable Development, with \$17,390,000 for posts and \$901,300 for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, supplies and materials and furniture and equipment. The decrease in post resources results from the abolishment of 1 P-5 post in line with General Assembly resolution 69/264, offset in part by the establishment of 1 P-4 post in the Small Island Developing States Unit for the implementation of resolution 69/15 on the outcome of the Third International Conference on Small Island Developing States (SAMOA Pathway). The decrease in non-post resources reflected: the removal of non-recurrent requirements related to the implementation of the outcome of the Fourth United Nations Conference on Sustainable Development and the support to the Third International Conference on Small Island Developing States,

pursuant to General Assembly resolutions 66/288 and 67/207, respectively; and further reductions under travel of staff that took into account the impact of the standards of accommodation for air travel in line with General Assembly resolution 69/264.

- 10. During the same period, extrabudgetary resources of \$1,565,000 was used to: (a) support the participation of representatives of developing countries and countries with economies in transition in a range of meetings related to sustainable development and in the intergovernmental meetings; (b) support analytical and technical cooperation work programmes related to energy and water; and (c) support activities relating to the Johannesburg Plan of Implementation, including among others, the SAMOA Pathway. The funding for the SIDS Unit's VRCP Capacity Building Projects has been exhausted risking non-continuance of this initiative.
- 11. In 2016, the JIU conducted a thorough assessment of the level of resources allocated to the Secretariat spanning seven biennium (2006 2017) and concluded that "resources have remained stable over a period in which the mandates have significantly expanded through successive resolutions resulting in additional tasks." Information in the paragraphs that follows contains data drawn from the JIU findings. These are reproduced here to highlight, reiterate and underscore the fact that not much has changed since in terms of allocation of resources to the Unit and additionally, to serve as a reminder of the need for serious consideration by the Assembly of the necessity to allocate additional provisions of resources to the Unit to enable their efficient delivery of the expended mandates given to them over subsequent years by the Assembly.
- 12. Graph: 1<sup>18</sup> illustrates the number of professional and higher staff in the SIDS Unit for 2006-2015 and was approved for 2016-2017 biennium. The same has remained largely unchanged.





- 13. The estimated cost of (professional and higher) staffing of the Secretariat, which is financed through the United Nations regular budget, amounted to \$2,518,873 for the biennium 2014-2015 and approved for 2016-2017 (in USD thousands)<sup>19</sup>.
- 14. Graph 2 illustrate the cost of professional and higher staff for the SIDS Units of DESA from the regular budget for 2006-2015 and approved for 2016-2017 (in USD thousands).

15. Concerning the evolution of extrabudgetary resources, those of the SIDS Unit of DESA fluctuated from one biennium to the other, peaking in 2010-2011 (see: graph 3 below).<sup>20</sup>


