Based on the United Nations Environment Assembly Resolution 2/4, UNEP successful incorporate SAMOA Pathway into its Programme of Work. In the absence of SIDS sub-programme, the activities in support of SIDS have been distributed across the sub-programmes. In order to monitor clearly the impacts of the UN Environment Programme activities, it would be require clear reporting systems within the existing Project Implementation Monitoring System of the Organisation.
