

i. Why are these considered a success?

These activities and initiatives are considered a success because they laid the foundations for PIDF's future interventions in these areas. The establishment of the Pacific Green Business Centre (PGBC) has opened up a number of opportunities for PIDF with the Private Sector. The six thematic areas of focus, i.e. Blue Economy, Renewable Energy, Sustainable Agriculture, Sustainable Transport, Sustainable Tourism and Green Packaging, have become the basis of new partnerships with Private Sector companies, in conjunction with Government and Civil Society. This portal alone contributes to at least eight of the SAMOA pathway thematic areas. The Pacific Blue Economy Conference explored the potential of the sector for the sustainable economic development of Pacific island countries.

PIDF's work in the sustainable transport sector (itself a SAMOA pathway thematic area) has been instrumental in supporting the Pacific in seeking as ambitious an outcome in negotiations within the IMO (for shipping emissions) and ICAO (for aviation emissions) as we have been able to achieve, with hard work and even harder negotiations in UNFCCC. The Sustainable Transport Forum and Expo that was organized in November (https://research.usp.ac.fj/pacific-islands-transport-forum-expo/), 2018 bringing together a large number of partners, was the culmination of this work. The resultant declaration (signed by Marshall Islands, Samoa and Tuvalu and open for other country signatories) now serves as a guide for future action in this regard. The initiatives in Renewable Energy have attracted interest from developing and implementing partners; the Solar Head of State are an implementing partner for a project supported by India, whereas the Global Green Growth Institute are an implementing partner in a project supported by KOICA.

The combination of some of these initiatives has also been advantageous. For example the PGBC has been used to support, promote activities and

involve the private sector in the other PIDF focus areas such as the Blue Economy, Renewable Energy, Sustainable Transport, Sustainable Tourism and Climate Change.

ii. What were the results? Please support with qualitative/quantitative evidence if possible/relevant.

These initiatives have produced a number of results and importantly are still PIDF's approach to development programme producing results. implementation (in contrast with conventional project implementation) does not revolve around ticking off a list of activities. PIDF's development initiatives are meant to empower people and local organisations to continue producing results following interventions, with the occasional injection of support by PIDF in specific areas. Some important results are the creation of a multi-stakeholder Green Packaging Steering Committee to phase out single-use plastic in Fiji (following the Pacific Blue Economy Conference), the development of a concept paper for the establishment of Blue Economy regional and national Blue Economy steering committees, think tank and knowledge hub. Interventions to revive the bamboo industry in Fiji, including the development of a Bamboo Centre and the creation of a Bamboo Association is supported by the PGBC as will be interventions related for the seaweed industry planned for late 2019. Similarly PIDF's interventions in the climate change area are closely related to the interventions related to sustainable transport and renewable energy. This interconnectedness between interventions is extremely important for PIDF, thus the establishment of only one Programme within PIDF - the One Pasifika Programme.

iii. Please elaborate on the critical factors that contributed to the intervention's success and any key lessons learned?

In most of these activities, the critical factor was PIDF's convening ability and its ability to build multi-stakeholder partnerships that include representation from government agencies, civil society, the private sector and academia. This ensures that interventions benefit from the strengths that these different stakeholders are able to bring. The other factor is to let other partners take lead roles in these interventions and PIDF offers them the support if and when needed.

b. Were there any other key results/outputs achieved? Describe their impacts, if any.

The output of the intervention establishing the Pacific Green Business Centre was an online portal with the aim of engaging Pacific private sector to support the development of the Green and Blue Economy in the Pacific as well as support the achievement of the SDGs and contribute to the achievement of the SAMOA Pathway thematic areas. This is and will

remain an on-going activity and slowing building into an important resource for Green Business. The Pacific Blue Economy Conference brought together for the first time all the different actors associated with this sector. It had many spin-offs and was so well received by all that it was decided to have this conference biennially with the next one to take place in late 2019. The Sustainable Transport Forum and Expo concluded with a declaration that underscored the work that needs to be taken in the sector in the coming years. The contribution of all the partners involved in the sector would be necessary to fulfil these needs.

4. Addressing Gaps and Challenges:

a. From among the programmes/projects that have been implemented by your organization over the reporting period, please elaborate on any implementation challenges that have been encountered.

As PIDF is a regional organisation, covering island countries scattered in the vast Pacific Ocean, implementation costs are relatively high. For this reason activities need to be strategically targeted to where they are mostly needed and done in ways that involve local expertise and interests and ensures continuation of activities in that are by these local entities following closure of projectsactivities. The creation of genuine partnerships around specific development themes (similar to or related to the SAMOA Pathway themes) is one of the most important elements of these interventions.

b. What have been the lessons learned and how will these be taken into account for the remaining implementation period of the SAMOA Pathway? (2019-2024)?

The multi-stakeholder approach has been successful in bringing the many partners active in the region to contribute towards common goals. Building better and stronger partnerships and networks has become an even more important component of PIDF's work and the organisation is feeling the need to dedicate adequate resources (human and financial) to this important area of work. These partnerships and networks will be organised around the SAMOA pathway themes and the SDGs to ensure a more cohesive and structured delivery mechanism towards these goals.
