Does your entity/organization/government have a SIDS Strategy? If not, are there any plans to establish one, including with the appropriate resources for implementation. (**1000 words**)

With a decision on 13 December 2019, the Government of Flanders (a region of Belgium) agreed to (continue to) support particular ocean-related projects of the IOC-UNESCO where SIDS are <u>priority beneficiaries</u>. We wish to highlight two of them:

- The Ocean Teacher Global Academy (<u>www.oceanteacher.org</u>): When selecting participants to attend (**OTGA**) training courses applicants from underrepresented MS (such as SIDS) are given priority (part of the OTGA Guidelines). This project is renewed in 2020 (OTGA-2) with a grant of approx. USD 980 000 (not exclusively for SIDS; for a 36-month period starting in 2020) see below;
  - A new project was initiated by IOC-UNESCO, Pacific Islands Marine Bio-invasions Alert Network (**PacMAN**; for a 36-month period starting in 2020), on the basis of the notion that invasive alien species pose a threat to sustainable development and undermine the efforts of small island developing States to protect biodiversity and livelihoods, preserve and maintain ocean resources and ecosystem resiliency, enhance food security and adapt to climate change. – see below.

# 3. Implementation of the SAMOA Pathway and Support to SIDS over the remining life of the SAMOA Pathway

Based on the call for action and other priority areas contained in on A/Res/73/4, please provide an indication of your entity's/organization's/government's proposed focus in the remaining life of the SAMOA Pathway. What outcomes are you seeking to achieve? (**1500 words**)

**OTGA-1** - Between 2018 – 2019, no less than 36 participants (learners) from SIDS were invited (i.e. supported to attend) OTGA training courses, including participants from the following countries:

- Cabo Verde 1
- Comoros 2
- Cuba 4
- Dominican Republic 9
- Fiji 3
- Jamaica 1
- Maldives 1
- Mauritius 5
- Sao Tome and Principe 1
- Seychelles 2
- Singapore 4
- Timor-Leste 2
- Tonga 1
- Trinidad and Tobago 1

Note: it is only possible to provide an numbers overview because the actual expenditure data are held de-centrally by the Regional Training Centres providing the actual courses.

**OTGA-2**: During the implementation of the new phase of OTGA (2020 - 2022) the IOC-UNESCO hopes to implement at least a Regional (or Specialised) Training Centre (RTC/STC) in one of the SIDS (likely the Pacific SIDS), so that oceans-related capacity development can be delivered from within a SIDS region. The project builds on the experience and the legacy of its predecessor and includes new initiatives and challenges now in place, for example, the 2030 Agenda and its SDGs and the UN Decade of Ocean Science for Sustainable Development. New, ready to deliver course topics will be made available online. The network of Regional Training Centres will be joined by Specialized Training Centres that can deliver very specific training topics. Training topics will also include tools that can help Member States achieving the SDGs as well as emerging topics such as Ocean Acidification and Blue Carbon, inter alia. OTGA-2 will foster collaborations beyond UNESCO/IOC to position itself as the training platform for ocean-related topics within the UN and beyond.

The Project will further develop the current OTGA model using the following key

objectives/activities:

- Develop a portfolio of packaged courses (related to the needs of IOC and other partners)
- Deliver courses online and/or blended learning, on demand
- Review the existing network of Regional Training Centres and explore opportunities to designate Specialized Training Centres (topic focused) and new Regional Training Centres in underrepresented areas, including languages.
- Focus on training needs stemming from the 2030 Agenda and its SDGs: the skills we need to achieve sustainable development
- Facilitate capacity development within the framework of the UN Decade of Ocean Science for Sustainable Development
- Use the Digital Revolution as a tool for Capacity Development
- Further develop and implement quality procedures and maintain ISO 29990 certification as a learning services provider to ensure the highest quality of training is delivered by OTGA

#### **Implementing Partners**

Besides several international organizations delivering CD relevant training related to ocean sciences, an IOC Circular Letter has been published on 28 February 2020 inviting IOC-UNESCO Member States to apply for hosting RTCs/STCs

**PacMAN**: based on the project plans, PacMAN is a 3-year (2020-2022) project, funded by the Government of Flanders through the Flanders UNESCO Trust Fund (FUST) for the support of UNESCO's activities in the field of Science, and co-funded by the Richard Lounsbery Foundation.

PacMAN will increase the technical and scientific capacity in marine invasive species early warning and early detection using international standards and best practices and applying novel technologies (DNA metabarcoding), and will provide information to implement national and international policies with the aim to reduce and prevent the introduction of new invasive species into the marine environment. Main activities of the PacMAN project include:

- A national marine invasive species monitoring plan
- Stakeholder forum
- Training courses for scientists and managers
- Species risk assessments
- Monthly in-situ monitoring surveys
- Cyber infrastructure, bioinformatics pipeline and sequence reference databases
